# **2021 Update: The Scam of the Century (Maybe the Millennium)**

## **Dr. Robert Malone, Father of mRNA Technology**

Contrary to what you would read in the mainstream media news, Dr. Robert Malone, is the inventor of mRNA vaccine technology. He is the named inventor on nine original mRNA vaccine patents. In addition to this, Dr. Malone has published close to 100 peer review papers, which have been cited over 12,000 times.

Live Attenuated Vaccines (LAV), such as polio, smallpox, and yellow fever, are injections of killed or weakened organisms. These vaccines present all the virus's proteins to the human body, and the body produces antibodies to these proteins.

The COVID-19 mRNA vaccine, as produced by Pfizer and Moderna, injected a single spiked mutated protein. The body produces antibodies to this one spiked protein. Malone warned that this mRNA technology risks heart inflammations and other adverse reactions.

# **Anthony Fauci Compared to Nazi Death Camp Doctor Josef Mengele**

## **NIH Admits to Funding Gain of Function Research**

NIH director, Lawrence A. Tabak, wrote in a letter dated 10-20-2021 to Rep. James Comer (R-Ky) that EcoHealth's "limited experiment" that the modified bat coronavirus made lab mice "sicker" than mice infected with the unmodified virus.

This admission from the NIH director directly contradicts Fauci's testimony to Congress, where he denied that the US had funded Gain-of-Function research in Wuhan.

## **Was COVID-19 Designed in a Lab?**

Evidence continues to mount almost daily.

Peter Daszak, World Health Organization investigator and EcoHealth Alliance president, stated that the SARS-CoV-2 was a natural jump, and to suggest it was created in a lab was a conspiracy theory.

Nikolai Petrovsky, a professor of endocrinology, first determined the virus had been modified to infect humans. However, his paper on the topic was rejected multiple times. (Think Censored)

As late as February 2021, the WHO actively helped the Chinese Communist Party (CCP) cover up the Wuhan lab origins of the SARS-CoV-2 virus. Only after an open letter signed by 26 scientists did the WHO state it was "frustrated" by the CCP's lack of access.

Reduces viral entry into the cell. Second, it helps utilize zinc to impair the virus replication, and it's an anti-inflammatory.

Contrary to Mainstream Media (MSM) reporting hydroxychloroquine, over two hundred clinical studies support using hydroxychloroquine for treating COVID-19. According to Dr. Peter McCullough, large-scale studies show a 50% reduction in hospitalizations and death for outpatients treated with hydroxychloroquine.

# Ivermectin

Ivermectin is already an FDA and WHO-approved drug. In 2015 a Nobel prize was given for the discovery of ivermectin and its impact on curing diseases. Clinical studies show that it is an effective treatment for COVID-19 by inhibiting the replication of the SARS-COV-2 virus. The federal, state, and many city governments' vaccine mandates and consequences of not vaccinating are coercion and directly violate the Nuremberg Code and UNESCO bioethics.

In addition, there can not be "informed consent" when the FDA asks for 75 years to release information and data for regarding the COVID-19 vaccine trials.

## **COVID-19 Vaccine Deaths**

**The US Government shut down the country on March 30, 2020, when the country counted 1377 deaths due to COVID-19.**

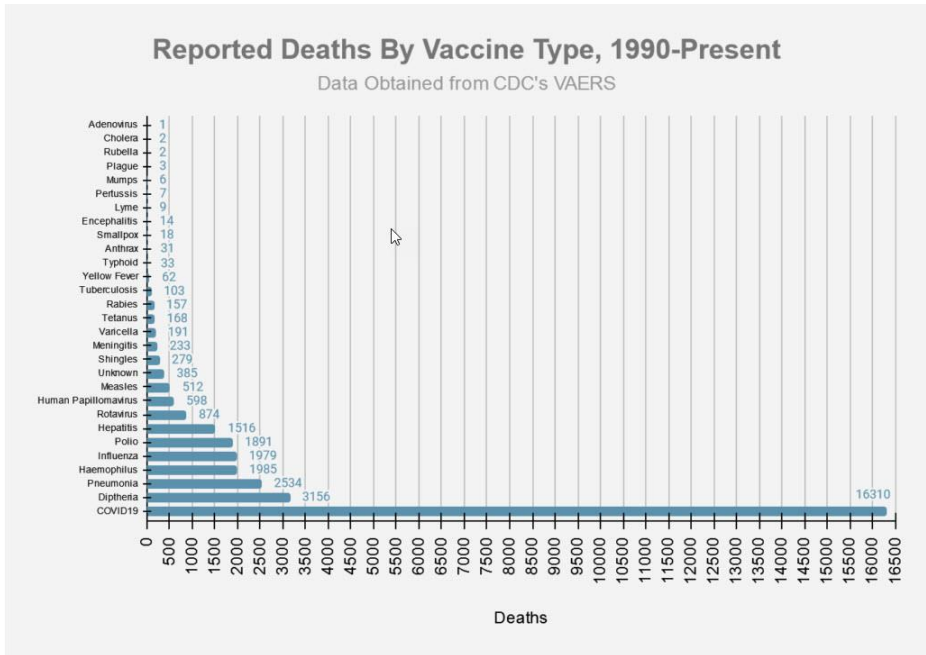
**As of October 1, 2021, the US has accumulated over 16,000 deaths in 10 months from the COVID-19 vaccine. So why isn't the government shutting down the vaccine inoculations? Anyone? ANYONE?**

To keep vaccine deaths in perspective, let's go back to 1976. In 1976, 45 million people were vaccinated for swine flu. In total, 53 people die from the swine flu vaccines.

Fast forward to 2021, 214 million people have been vaccinated for COVID-19. As of October 1, 2021, The CDC reports 16,927 deaths. This death count may only be a fraction of the actual deaths, as VAERS data is covered up as part of the Noble lie to prevent vaccine hesitancy.

In any case, if we translate the death rate of the swine flu vaccine (1976) to the COVID-19 vaccine, we would expect only 253 people to die from the vaccine. However, with 16,927 dead, the death rate for the COVID-19 vaccine is 72X deadlier than the vaccine for the swine flu.

The above chart is a little outdated. As of October 1, 2021, there are 16,927 deaths from the COVID-19 vaccines reported by the CDC.

## **Lies by Blaming the unvaccinated for the pandemic - hospitalizations.**

Addled President Biden made a speech blaming the unvaccinated Americans for the pandemic, virus mutations, current COVID-19 hospitalizations, and slow economic recovery.

## **Proof from Israel - The ineffectiveness of the COVID-19 vaccine**
